- 1. Eligibility:** The Johnny's School Spirit Extravaganza is open to participating schools in Michigan and Indiana. Voters must be 18 years of age or older as of their date of entry with a valid Social Security number. Individuals ages 13 to 17 years of age are eligible to participate in Contests with the approval of a parent or legal guardian, provided that the parent or legal guardian is a legal U.S. resident at least 18 years of age at the time of entry with a valid Social Security number and resides in Michigan or Indiana. No purchase necessary. This giveaway is subject to federal, state, and local laws and regulations and void where prohibited by law.
